本核數師(以下簡稱「我們」)審計了載於第45頁至第223頁 南洋商業銀行有限公司(「貴銀行」)及其附屬公司(統稱「貴 集團」)的綜合財務報表,包括於2015年12月31日的綜合資 產負債表與截至該日止年度的綜合收益表、綜合全面收益 表、綜合權益變動表和綜合現金流量表,以及主要會計政策 和其他附註解釋資料。

We have audited the consolidated financial statements of Nanyang Commercial Bank, Limited (the "Bank") and its subsidiaries (together, the "Group") set out on pages 45 to 223, which comprise the consolidated balance sheet as at 31 December 2015, and the consolidated income statement, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated cash flow statement for the year then ended, and significant accounting policies and other explanatory information.

Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the consolidated financial statements are free from material misstatement.
