## Notice of designated investment transactions secured by the Two-factor authentication on Internet and Mobile Banking

Dear Valued Customer,

Thank you for choosing Nanyang Commercial Bank ("the Bank") Internet or Mobile Banking.

In order to enhance security control for online securities and other investment services, Designated Investment Transactions Secured by the Two-factor Authentication is now implemented on Internet and Mobile Banking. Starting from 22 July 2018 onwards, Precious Metal/FX Margin, Precious Metal (i.e. Notional Precious Metals Passbook Account), Currency Linked Investments, Investment Deposit and Structured Investments are newly added. Simultaneously, in order to ensure continued transactions, you must fulfill the following requirements when conducting designated investment transactions through Internet or Mobile Banking,

- (i) when using security device for verification, email address or mobile number is essential for receiving specified transaction notification,
- (ii) when using "SMS One Time Password", email address is essential for receiving specified transaction notification,
- (iii) when choosing to trade in joint account, the Bank will send the specified transaction notification to the registered e-mail address or/and mobile phone number of the joint account in accordance with (1) and (2) above.
